If you claim that you are not resident in the United Kingdom (UK) and that any UK income tax deducted from your earnings should be repaid, you must complete this form.

- 1 No repayment on the grounds of non-residence can be made of tax deducted from
 - earnings for duties performed on voyages between UK ports
 - earnings for duties performed on voyages between UK ports and oil and gas installations in the UK sector of the continental shelf
 - earnings for all other duties performed within the territorial sea of the UK unless the voyage involves onward passage to/from a foreign port
 - earnings for duties performed in the UK sector of the continental shelf in connection with oil and gas exploration or exploitation
 - earnings for days spent in port or onshore in the UK
 - (i) working in port or onshore
 - (ii) standing by or awaiting appointment.
- 2 A claim on the grounds of non-residence may be made if you are
 - absent from the UK during the whole of the tax year (ended 5 April), or
 - not ordinarily resident in the UK and visit the UK for a temporary purpose only without any intention of establishing your residence here, and you are not in the UK for a period, or periods, amounting to 183 days or more in the tax year (ended 5 April).
