

## 'Test in Live' Information

### Background

The 'Test in Live' (TIL) functionality is essentially a testing facility for users. It allows users to submit files to the Live Gateway using Live credentials but no HMRC systems are updated.

Any submissions identified as TIL are validated and treated as Live submissions. The validation responses are identical to Live returns but as this is a test service will result in a dummy IRmark receipt being returned in the success\_response. A normal error message will be returned if the TIL submission is unsuccessful.

### What is required

To submit a TIL submission to the Live service the following details should be included in the file:
