

## **KEEP THIS LETTER!**

### **YOUR NOTICE TO FILE YOUR EMPLOYER ANNUAL RETURN ONLINE FOR 2007-08**

This letter tells you about filing your Employer Annual Return online for the tax year 2007-08.

Our records show that you had between 50 and 249 employees in your PAYE scheme on 29 October 2006.

This means that for 2007-08 you must file your Employer Annual Return (P14s and P35) online (or an agent can file for you) or you will face a penalty.

#### **How to appeal**

You can appeal if you think you had fewer than 50 employees on 29 October 2006.

Write to the address above within 30 days of receiving this letter and tell us how many employees you actually had on 29 October. Please include your Employer PAYE reference.

#### **2006-07**

This letter does not change what you have to do about online filing for 2006-07.

From 2006-07 we will not send you a paper P35 if we told you that you had to file online for that year.

#### **2008-09**

From April 2008, if you have 50 or more employees, you will have to send in-year forms P45(1), P45(3), P46 and pension notifications online.

#### **Do more online!**

There are also lots of other ways you can do business with us online. For example you can receive tax code numbers (P6s, P6Bs and P9s) from us and you can send us forms P11D.

#### **Electronic payment**

You can also pay your monthly PAYE, National Insurance contributions, Student Loan and Construction Industry scheme deductions electronically.
