Introduction

Working Families' Tax Credit (WFTC) is a tax credit available to families with at least one adult in remunerative work for at least 16 hours per week, and who are responsible for at least one child under 16 (under 19 if in full-time education up to A-level or equivalent standard). It is payable to two-parent and one-parent families.

Awards of WFTC cover 26 weeks. These tables cover families in receipt of WFTC at 31 August 2002 (that is, having awards with start and end dates spanning that date).

WFTC replaced Family Credit (FC) from 5 October 1999. Time series of the number of families receiving WFTC and FC are also shown, but for dates before November 1997 figures are available only for such cases dealt with by the Great Britain office (that is, excluding cases dealt with by the Northern Ireland office).

The main aggregates, and some detailed figures, are derived from an analysis of all awards current at 31 August 2002. They are based on an extract taken about three months later, and are consistent with the figures in the publication "Working Families' and Disabled Person's Tax Credit Statistics. Geographical analyses. August 2002", which is available on the Inland Revenue website (see inside front cover).

Other detailed figures are estimates based on a scan of a random 5 per cent sample of all awards dealt with by the Great Britain office, and all awards dealt with by the Northern Ireland office, as they appear on the database about three months after 31 August 2002. Consistency with the main aggregates has been achieved by applying appropriate weights to awards in each of 16 strata. These strata are defined (a) by whether the recipient family has one or two adults, b) by whether or not the main earner is self employed, (c) by whether or not the award includes a childcare tax credit and (d) by the office dealing with the case.

The source(s) used for each table are noted at the foot of the table. The figures derived from the 5 per cent sample are estimates subject to sampling error (see Appendix A), and such estimates based on fewer than 25 cases are shown as '-'.

The number of recipients in each region, local authority and parliamentary constituency are included in the Geographical analyses publication.

Main findings

There were 1,355 thousand families receiving WFTC awards at 31 August 2002 1.0 per cent higher than at 31 May 2002 and 6.6 per cent higher than a year earlier.

The average award was £85.83 per week.

A total of 2.64 million children were in recipient families. 719 thousand (53 per cent) of the recipient families were headed by lone parents; these families included 1.19 million children - an average of 1.6 per lone parent family. The other 636 thousand families were headed by couples; they included 1.46 million children - an average of 2.3 per family headed by couples.

Nearly half of lone parent recipients had administrative, secretarial or personal service occupations. For couples, over half the main earners had skilled trades, were process, plant or machine operatives or had elementary occupations.

793 thousand (58 per cent) of the recipient families benefited from the 30-hour credit.

For 175 thousand recipient families (13 per cent), their award included a childcare tax credit. The average value of this credit for those benefiting was £40.69 per week.

The average gross weekly earnings of the main earner in the recipient families was £176.

Section 1 : Time series

This section shows back quarterly series for the number of recipients of Family Credit and Working Families' Tax Credit, and their average weekly awards.

For dates up to August 1999, the awards are of Family Credit.

For November 1999 and February 2000, the recipient families are a mixture of Family Credit and Working Families' Tax Credit recipients. Family Credit recipients are those with awards starting up to 30 September 1999 and still current at the reference date.

From May 2000, all the awards are of Working Families' Tax Credit.

From May 2001, the figures initially published for each reference date have been based on extracts covering all awards current at the reference date according to data available three months later. They are consistent with the figures published in the geographical publications with the same reference dates.

For earlier dates the figures were estimates based on data for a 5 per cent sample of all awards in Great Britain, and all awards in Northern Ireland, again extracted about three months later.

To provide consistent estimates over the change of source, figures for May 2001 were compiled on both bases. The differences are due to sampling error in the sample estimates (see Appendix A).

The final figures, shown here for months up to May 2002, are slightly different to those initially published. They take into account awards made, disallowances and changes to termination dates that occurred after the data for the initially published figures were extracted. The sizes of the changes are estimated by analysing the 5 per cent sample of all awards (all awards in Northern Ireland) extracted six months after the reference date.

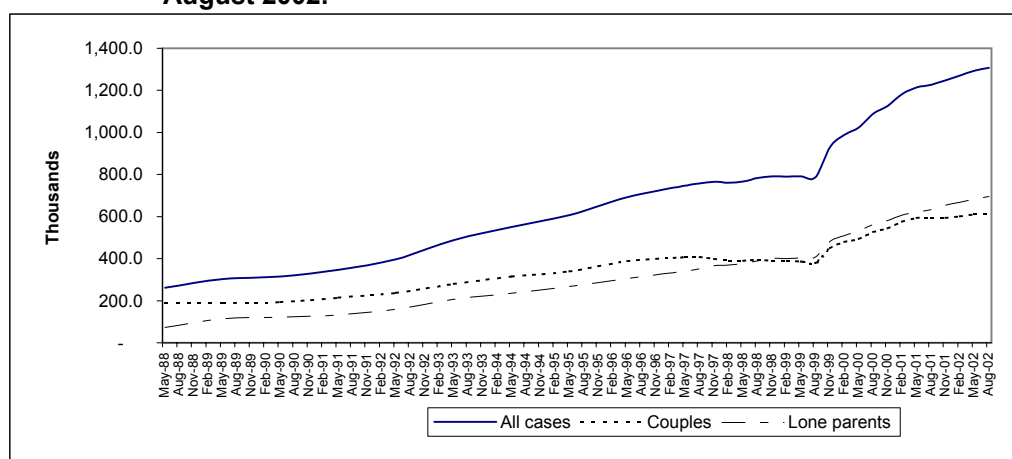
Chart 1 : FC/WFTC recipients by family type, GB office, May 1988 - August 2002.

Chart 2 : Average FC/WFTC award by family type, GB office, May 1988 - August 2002.

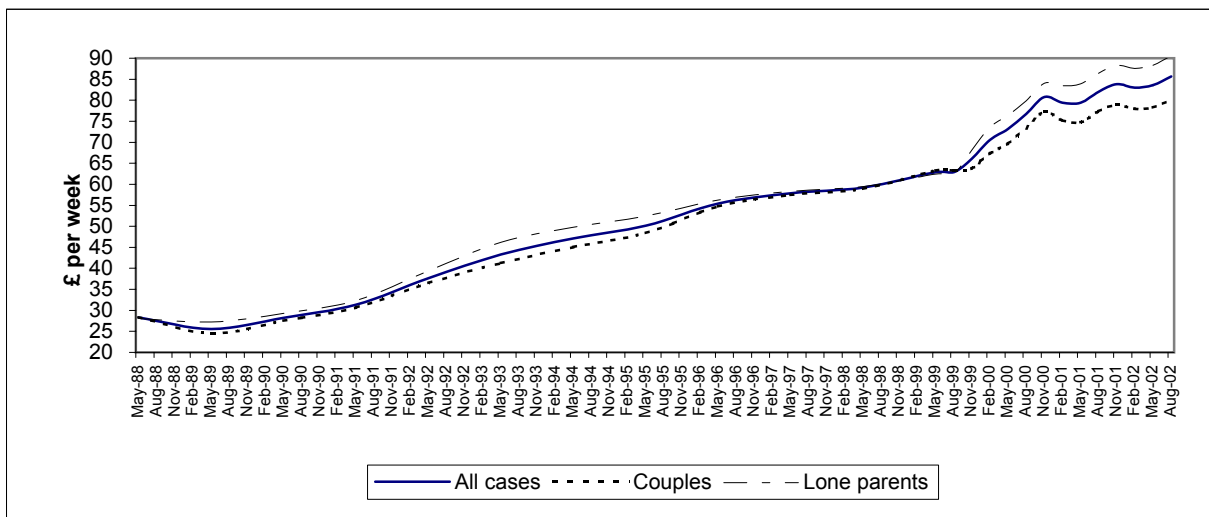

Chart 3 : Distribution of recipient families by type.

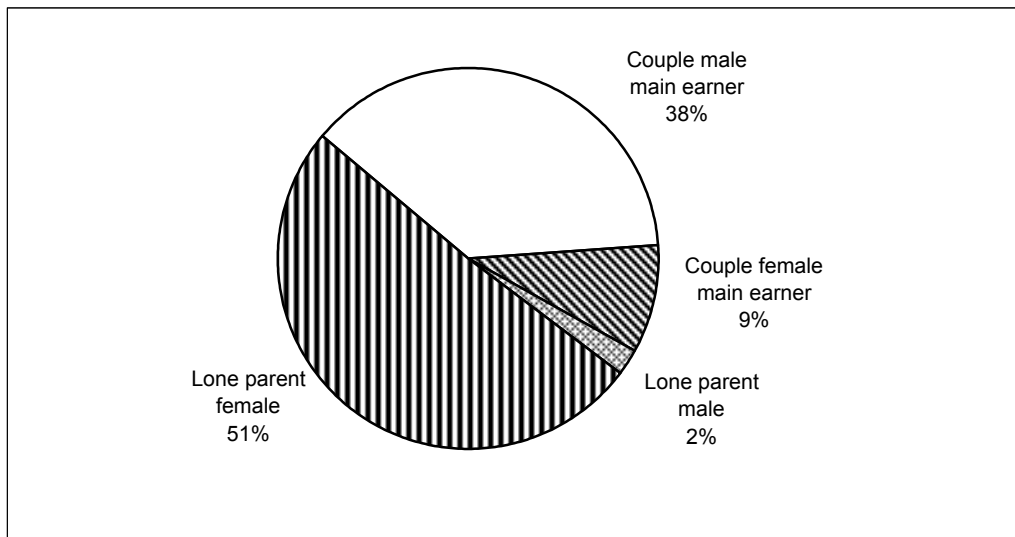

Chart 4 : Distribution of recipient families by age of the main earner.

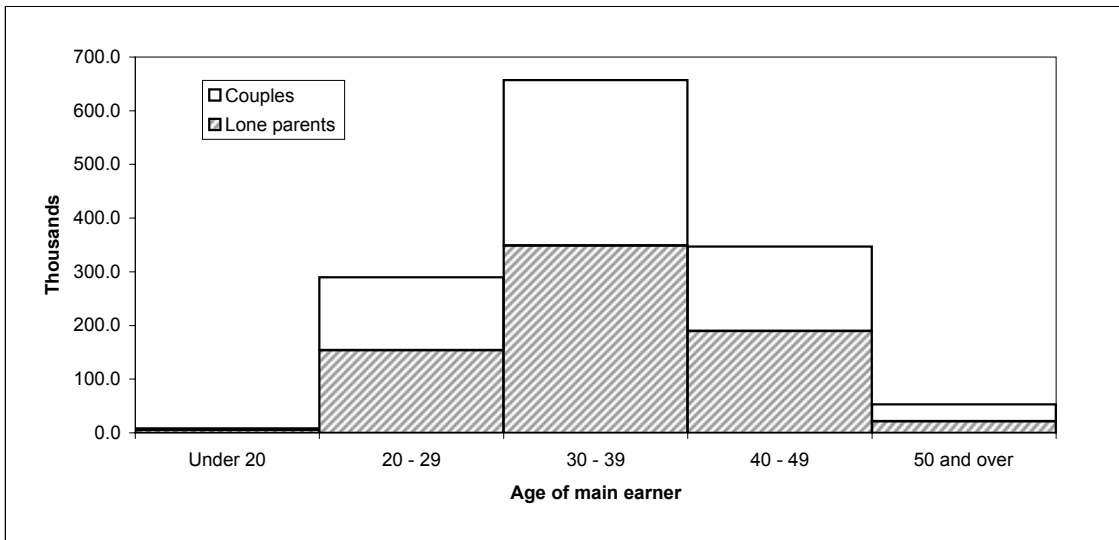

Appendix A : Sampling error

Some figures contained in this publication are based on a 5% sample of all WFTC awards dealt with by the GB office, as indicated in the source descriptors for each table. The sample is drawn to represent the characteristics of all recipients on the WFTC system.

Therefore, if the number of cases in a sample with characteristic A is 500, we can say that the estimated number of recipients with characteristic A on the WFTC system is equal to 500 multiplied by 20, that is, 10,000 cases.

The sample which has been taken is just one of many different samples which could be taken, therefore the total calculated number of recipients with characteristic A is only an estimate of the actual number of recipients. If another sample had been taken then the estimate for the same characteristic may have been slightly different.

The table overleaf shows the amount of variation that can be expected from the estimated number of recipients with a certain characteristic.

For example, if from a 5% sample there are 500 recipients with characteristic A then the estimated number of recipients in the population with the same characteristic is 10,000. We could reasonably expect the actual figure to lie between 9,150 and 10,850.

Formula

Two formulae are used to calculate the standard error and the associated confidence intervals. For samples with less than 30 cases the binomial distribution is used to calculate the standard error. For samples with greater than 30 cases the normal approximation to the binomial is used. The normal approximation formula used to calculate the standard error is:

$\sqrt{(1-F)S} \frac{1}{F}$, where F is the sampling factor (e.g. 0.05 for a 5% sample) and S is the number of sample cases with the characteristic.

In an example where there were 50 sample cases with characteristic A taken from a sample representing 5% of the population, the standard error is:

$$\sqrt{(1-0.05)50} \frac{1}{0.05} = 137.8... \approx 138$$

There is a 95% probability that the actual population value falls within 1.96 standard errors of the grossed up sample value. For the above example this would be:

$$(50 / 0.05) \pm 1.96 \times 138 = (730, 1270)$$

This range is known as the 95% confidence interval.

Please note that this method can only be applied to estimates of number of recipients and not to estimating the sampling error associated with averages such as average weekly award etc.

Such codes have been allocated to the major group with the largest number in employment nationally. For example, the definition of "Sales Assistants" covers occupations in both major groups 7 and 9. Nationally, however, the majority of those in employment covered by "Sales Assistants" are in occupations falling within major group 7. "Sales Assistants" has therefore been allocated to major group 7.
